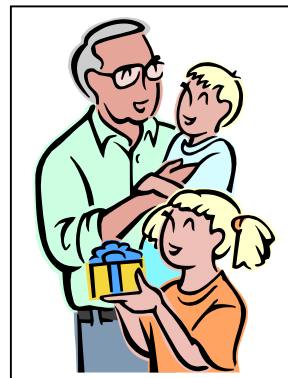

## **A MESSAGE FROM YOUR FINANCIAL SECRETARY**

June 2010

### **COUNCIL DUES**

Your FS has been very patient when dealing with the **3** Brothers who are procrastinating with the payment of their **2008, 2009 & 2010** Membership Dues; the **3** Brothers who are late on their **2009 & 2010** Membership Dues, and the **17** Brothers who have not yet paid their Membership Dues for Year 2010. The numerous reminder notices, in the form of telephone calls, emails and snail mail, which have been sent to these Brothers over the past six months, have not produced expected results.

With high hopes of gaining the attention of these **23** Brother Knights, reminder notices were mailed, via snail mail, to them on June 4, 2010. Each of the envelopes mailed had the following phrase printed in large red letters just above the name and address: **IMPORTANT DOCUMENT ENCLOSED!! REQUEST RESPONSE!**

Each reminder notice has a memo requesting that I, your FS, be called at 657-2445 to acknowledge receipt of the communication. As of June 15, it is so very disheartening to report that **NOT** a single Brother Knight has responded to the written request mailed on June 4th.

If someone else in your household gathers in the mail from the mail box please be sure they give you the mail that is addressed to you. None of the mail has been returned by the Postal Service as being undeliverable. Therefore, it has to be believed the mail has reached the intended address and one of two or more things has happened:

1. The person bringing in the mail from the mail box did not give you your mail.
2. You did receive the mail and have not yet opened the envelope.
3. You did open the envelope and put the notice aside to take care of the matter later.

On June 10 and June 12, a member of the Council Retention Committee made telephone calls to twenty one (21) of the 23 members (2 have unknown telephone numbers). Five said they would send payment within a week. Found out that the telephone numbers of four Brothers are no longer in service. This leaves sixteen (16) who have not answered the request left on the telephone answering machine – please call back!

As of June 15<sup>th</sup>, it is very saddening to report that **only 1** payment has been received. Be a true Brother Knight and Catholic Gentleman to take care of your obligation, and be faithful to the Oath taken on your Initiation into the Knights of Columbus. Please remit the payment for Membership Dues now. If you are in a financial bind, please contact the Grand Knight, the Financial Secretary, or any Council Officer. **PLEASE DO TAKE CARE OF THIS VERY IMPORTANT MATTER!!**
